# GOPALPUR INDUSTRIAL PARK

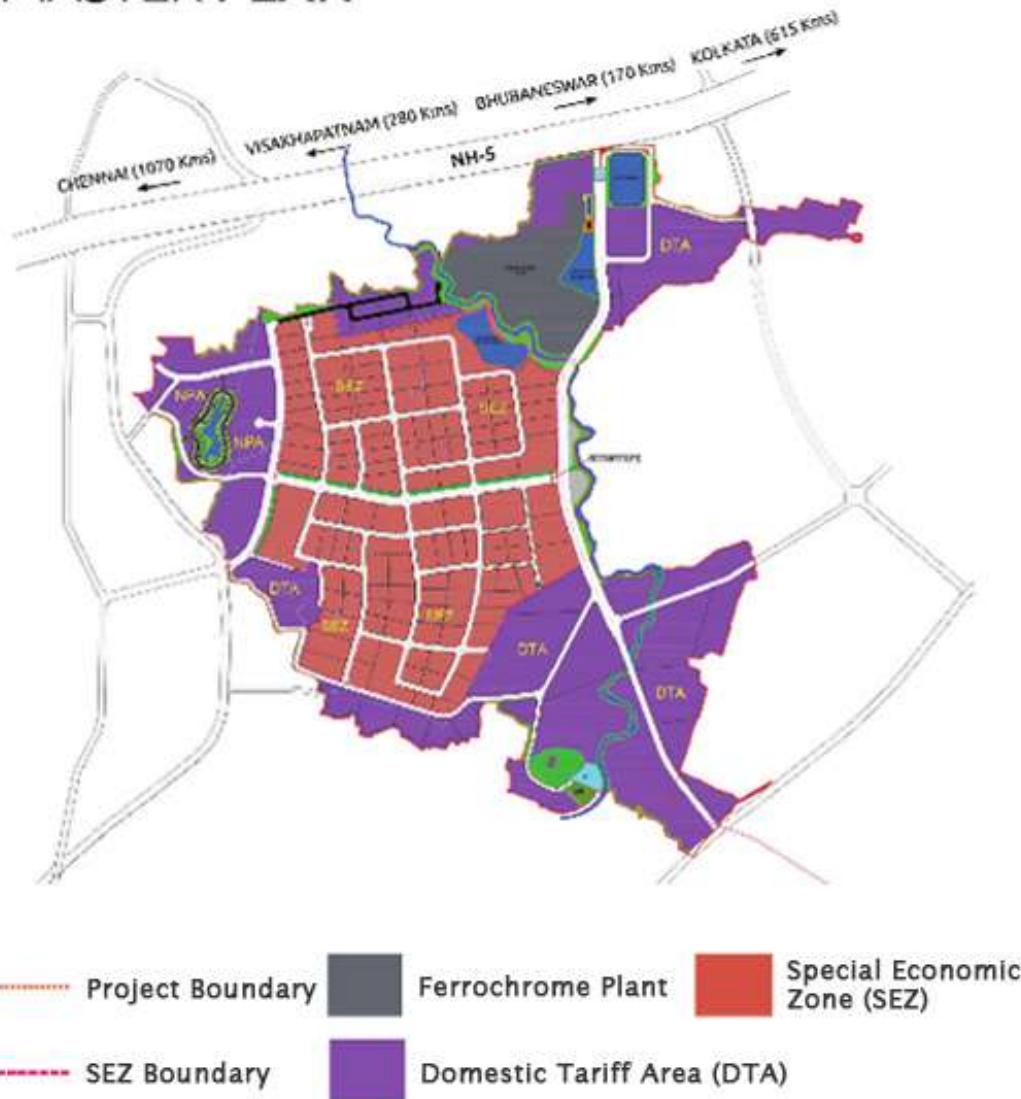
Gopalpur Industrial Park is located on the east coast of India, in the state of Odisha. The project is spread across 1202 Ha of contiguous land. It comprises of:

- ◆ 500 Ha of multi-product Special Economic Zone (SEZ) - Suitable for export oriented manufacturing
- ◆ 702 Ha of Domestic Tariff Area - Suitable for Indian market
- ◆ Social Infrastructure for the people living within the Industrial Park

The Industrial Park offers quick setup facility with ready Environment Clearance from MoEF, water and power infrastructure facilities and clear land title. The J N TATA Technical Education Centre, located inside the Industrial Park provides training on various trades. This provides skilled manpower for the industry. Designed by Surbana Jurong Pvt. Ltd. of Singapore, on walk to work concept, the Industrial Park envisions to generate direct & indirect engagement for approximately 15,000 persons.
